Funding for publication of research falls into the following categories: Funding for the production of theses or dissertations will be available to undergraduate and graduate students on a limited basis, and will be limited to a maximum \$400 award per student while funds exist. Priority will be given to the following types of expenses:

• Submission fees charged by a subscription-based and open access journals to help to fund editorial and peer review administration.

Printing charges assessed by a journal to cover the cost of printing, and particularly color printing.
 Publication fees, charged by certain open access journals, also known as author publishing charges or article processing charges (APCs).

• To buy books, software (transcription, quantitative or qualitative research or data analysis software), materials, supplies, or small equipment for a specific student research, scholarly, or creative activity project.

• Photocopying or other supplies necessary for a specific study.

• **PLEASE NOTE**: Costs related to any the production and submissions for publication of a student's thesis or dissertation are NOT eligible for funding under this program.

5.0 V. AMOUNT OF AWARD

<u>With the exception of thesis or dissertation awards, which are limited to \$400,</u> The Student Research Fund awards qualified applicants up to \$700 for the support of research, scholarly and creative activities conducted under the guidance of sponsoring faculty members.
