8. UNFINISHED BUSINESS

- A. Discussion Item: Project Rebound

The Chair of CSULB's History Department Dr. David Shafer spoke with Cabinet about Project Rebound and the potential for bringing CSULB into the program and creating collaboration. Dr. Shafer has been working with other faculty members to work on different options available for bringing the project onto campus and setting up an infrastructure on campus for the re-entry of formerly incarcerated students into higher education. There will be a renewal for CSU's to get money for the program who weren't able to get it before.

Dr. Shafer and his team have reached out to students and received interest and feedback in the program, also President Conoley is in support of bringing the program to campus, and is hoping to also work with ASI. The team is currently in the process of reaching out to donors in order to be able to apply for the money through the institute.

Sec. Guest asked about the safety of students on campus and what CSULB would do to ensure student body is protected. Sec. Lendrum responded that CSULB currently does all they can do legally, once formerly incarcerated students are released they have a right to enroll. Sec. Lendrum understood the concern, but noted that most times the chance for an education changes the lives of formerly incarcerated students and gives them a fresh start.

Dr. Shafer reminded that the school can't restrict who comes onto campus, and that there isn't a box on applications for people to check, so there isn't a way of telling how many formerly incarcerated are on campus. But the point of the program is to provide infrastructure to people in prison now so that they have something to look forward to, that way they aren't just dumped with no options once they are released.

9. NEW BUSINESS

- A. Discussion Item: Potential Tuition Increase

President Flores stated that at the CSSA meeting this weekend he learned about a potential increase in tuition for students that would go into effect from 2017-2018. For undergraduate students the increase could be \$270.00 for the year, for graduate students \$438.00 for the year, and for credential students potentially \$312.00 a year.

President Flores said he will be looking into how students with/without financial aid will be effected. The next step is for students to share their stories and how they will personally be effected. President Flores is concerned with CSSA's lack of support and is considering creating a campaign to stop the SIRF fee that was intended to create more advocacy for students, but if they aren't willing to help get the CSU's funding, then maybe we should consider stopping the SIRF fee.

President Flores will be contacting President Conoley about holding a forum on campus to inform students, that way there is unity and not a split on how to approach the situation. Potentially there could be phone banking to state legislators and possible protests. He said that every CSU is looking to see what CSULB will do, since they voiced their disagreement during the CSSA meeting.

Sec. Lendrum said to reach out to organizations that are close to ASI and said it is time to unite with a spirit of togetherness, and to allow President Conoley every opportunity to get behind them and support them. He said CSU should be able to find another means to sustain itself rather than through increasing student tuition.
