# B. Additional Proceedings

- 1) Discussion Item: Legality of Marijuana Brochure
  - Chief Justice Contreras stated that it's a new law rundown of what they should be aware of
  - Students caught with marijuana can still be disciplined
  - Creating brochure and collaborating with University Police Department and faculty

San Miguel suggested to the board that they reach out to the Student Health Center and check if they already have brochures made on marijuana, as they will need to prioritize how they utilizing their remaining budget for the semester. San Miguel also suggested creating a video instead which can be housed on the website and shared via social media, as well as adding it to their Know Your Rights webpage.

2) Discussion Item: Women's Conference

- Chief Justice Contreras reported that the workshop is a work in progress with Sen. Mejia
- Low budget may have to scale down initial plans
- Judiciary will meet with Sen. Mejia after to discuss possible ideas
- 3) Discussion Item: Protesting Rights

  - Looking to be more student oriented

San Miguel stated that last semester Chief Justice Vo had the idea of utilizing case studies to work through how to handle issues that have arisen on other campuses. San Miguel also recommended connecting with interested students from last semester to help brainstorm such as Commissioners Merino and Cail.

  - Chief Justice Contreras asked Justice Phong to help get information from Housing students as to what they would like to see at this workshop

  - Chief Justice Contreras stated that the grade appeal website may be difficult for students to understand the process
  - Possibly offer assistance through the website
    - Contact information for Chief Justice Contreras who can then refer the students to associate
      justices to help them that are not assigned to their college

  - Chief Justice Contreras stated that the opposition to the tuition increase campaign will be a collaboration with Lobby Corps and Senate, Contreras has been in discussions with Sen. Carancho
  - Possibly hosting Info Sessions with students on what the tuition increase is, when it will happen, and how they can participate in the fight against it.
