Senate has discussed a resolution to dissolve the Board of Elections and giving Judiciary more responsibilities: hearing board, monitor campaign activities with the Government Elections Officer, and candidates who will be running for office will need to recuse themselves from the decision-making and hearings as it relates to elections.
