### 3. INVOCATION: Min Yao, CSULB Vice President & Chief Information Officer

Dr. Yao spoke about Steve Jobs, who was the chairman, chief executive officer (CEO), and a co-founder of Apple Inc.

Steve Jobs was an entrepreneur, an inventor, industrial designer, and visionary leader. He co-founded Apple Company in 1976. A year later, in 1977, Steve Jobs and his business partner upgraded the computer and named it the Apple II. Apple II was one of the first highly successful mass-produced personal computers. It sold well. Because of Apple II, Steve Jobs and his business partner became famous and did well financially.

Steve Jobs continued his passion for new and better computers. In 1984, Steve Jobs introduced the first Macintosh computer. It was again a big success. The Apple Company expanded into a big company. However, there were company politics and internal power struggle. Steve Jobs was forced out Apple Company in 1985. Steve Jobs left Apple Company with a team of followers to form a new company.

After Steve Jobs and his key team left, Apple Company went a downhill path. No new products were designed and the market was tired of the same look and design of Apple computers.

In 2003, CBS 60 Minutes program interviewed Steve Jobs and asked him about his secret for success. It was during that interview that Steve Jobs said that:

"Great things in business are never done by one person. They're done by a team of people".

Based on Steve Jobs' saying, I would like to say that great things in education are never done by one person. They are done by a team of people. Teamwork is the key to success at work. I encourage all of you to leverage teamwork in your school work, in your career, and in your family life.

Teamwork will make you more successful than your individual efforts.

### **10. NEW BUSINESS**

    - Some members of Judiciary are not fulfilling duties of the bylaws

- Originally, bylaw stated there would need to be a student petition and 5% of the student body would need to sign the petition. This would then be sent to the VP and be heard in front of the Senate who would act as a court and remove the Justice by a 2/3<sup>rd</sup> vote.
- Change the impeachment process stating that it is the President's decision since they are elected by the president.
  - Along with the Chief Justice or Associate Justices
  - No longer Senate responsibility

## B. Non-Legislative Business

1) Discussion Item: Racist Incidence at Cal Poly San Luis Obispo Sen. Yamagiwa brought this discussion item to the board to discuss the fraternity incidences of vandalism.

Sen. Ngazimbi noted how well created the images were that were used. The President of the University, President Armstrong, has said that there is no racism on campus.

Bose noted that President Armstrong has suspended all fraternities and Greek Life organizations on campus, indefinitely.

### C. Executive Business

1) Action Item: 2018-2019 ASI Consolidated Operating Budget Proposal (1<sup>st</sup> Reading) Haller gave a presentation on the Budget Proposal:

### Revenue from AS Fees

- Reduction of \$70,812 from the 17/18 adopted budget
- Results from a reduction in headcount enrollment
- Possibility some of this revenue will be recovered through additional admissions
- Will require the use of \$17,529 from prior year's retained earnings

### **Income from Operations**

- Associated Students anticipates the generation of \$2,283,843 in income from operations
- Overall increase of 6.70%
  - \$30,952 increase in grants and contracts for IPCDC
  - o \$73,226 increase in recovered expense, primarily from childcare fees
  - \$38,000 increase in gross sales of recyclable commodities
- Increases are based on prior and current year actual performance
  - Personal Service Expenses:
  - The total budget for payroll and benefits increased 6.08%
  - o Payroll
    - Full-time payroll increased by 2.78%
    - Part-time payroll increased by 8.25%
    - Salaries
      - No cost-of-living or merit increases for full-time positions
    - Student Assistant Wages
      - Increased by \$93,277
      - Includes a 4.55% increase resulting from California minimum wage increase
      - Will be applied to all student assistant positions to avoid wage compression

### Benefits

- Mandated Benefits
  - Workers' Compensation premiums decreased by \$4,184 or 22.17%

- Unemployment Insurance rates expected to decrease from 0.27% to 0.22% of payroll
- Employer contributions for FICA and Medicare have been budgeted at 7.65% of applicable wages
- Discretionary Benefits
  - 7.8% increase in Anthem Blue Cross HMO medical premiums and a 9.9% increase in PPO medical premiums effective January 1, 2018.
  - 6.5% increase in Kaiser medical premiums
  - Vision, dental and life insurance premiums are not expected to increase
  - ASI's contribution for employee and dependent coverage budgeted at corresponding contribution rate for CSU employees
  - Includes \$65,392 for the payment of medical and/or dental benefits for six retirees.
- Pension Benefits
  - Continued participation in the Public Employees' Retirement System (PERS)
  - ASI will continue to deduct mandatory employee contributions from each salaried employee's semi-monthly paycheck
  - ASI also pays employer contributions to PERS at the rate of 26.75% of Tier 1 wages, 10.99% of Tier 2 wages, and 7.266% of PEPRA wages.
  - Represents an expense of \$284,171 which is an increase of \$64,233.

## Operating Expense and Equipment

- Overall budget decreased 4.98%, or \$145,548
  - o Includes a \$99,320 budget reduction in Capital Outlay resulting from the temporary suspension of the annual capital outlay program
  - Should equipment need to be replaced or building improvements become necessary, ASI will draw from the Reserve for Capital Expenditures

### Revenue from USU Fees

- Reduction of \$212,832 from the 17/18 adopted budget
- Results from a reduction in headcount enrollment
- Possibility some of this revenue will be recovered through additional admissions
- Offset by budget reductions and reductions in contributions to reserves
- Will not require the use of prior year's retained earnings

## **Income from Operations**

- The University Student Union anticipates the generation of approximately \$2,016,088 in income from operations
- Minor increase of .94%.
  - o Increases in non-taxable sales, taxable sales, and facility rentals in the Commercial Services area
  - o SRWC Membership revenue has remained consistent with prior year
  - Personal Services Expenses
  - The total budget for payroll and benefits increased 2.37%
  - Payroll
    - Full-time payroll decreased by 2.35%
    - Part-time payroll increased by 11.18%
    - Salaries
      - No cost-of-living or merit increases for full-time positions
    - Student Assistant Wages
      - Increased by \$239,146
      - Includes 4.76% increase resulting from California minimum wage increase
      - Will be applied to all student assistant positions to avoid wage compression
- Benefits
  - Mandated Benefits

- Workers' Compensation premiums decreased by \$4,1841 or 22.17%
- Unemployment Insurance rates expected to decrease from 0.27% to 0.22% of payroll
- Employer contributions for FICA and Medicare have been budgeted at 7.65% of applicable wages

## Discretionary Benefits

- 7.8% increase in Anthem Blue Cross HMO medical premiums and a 9.9% increase in PPO medical premiums effective January 1, 2018.
- 6.5% increase in Kaiser medical premiums
- Vision, dental and life insurance premiums are not expected to increase
- ASI's contribution for employee and dependent coverage budgeted at corresponding contribution rate for CSU employees
- Includes \$91,958 for the payment of medical and/or dental benefits for seven retirees.

### Pension Benefits

- Continued participation in the Public Employees' Retirement System (PERS)
- ASI will continue to deduct mandatory employee contributions from each salaried employee's semi-monthly paycheck
- ASI also pays employer contributions to PERS at the rate of 26.75% of Tier 1 wages, 10.99% of Tier 2 wages, and 7.266% of PEPRA wages.
- Represents an expense of \$353,612 which is an increase of \$88,789.

## Operating Expense and Equipment

- Overall budget decreased 2.93%, or \$130,767
  - o Includes a \$83,757 budget reduction in Utilities
  - Fund Accounting
- ASI maintains financial resources in accordance with the principles of fund accounting
- Resources for various purposes are classified into separate funds
  - Ensures observance of limitations and restrictions placed on the use of resources
- ASI has two funds
  - Associated Students General Fund
  - o University Student Union General Fund
- Funds cannot be co-mingled
