12. CLOSING COMMENTS

Cindy, SustainU: congratulated Arechiga on their election.

Miguel Lopez, student: thanked board for reconsidering and their support on a tough issue.

Hugo Solorzano, student: whatever your decision is, you can't kill the spirit of resistance.

Lendrum: voiced appreciation to those who gave public comment; reviewed their committed involvement in fighting for diverse student/faculty representation; voiced concern and disappointment over divisive effects of last week's AB1460 resolution.

Torres: commended co-senator Williams for their dedicated efforts; voiced disappointment in comments that were made before/after vote, especially after being encouraged by vice president to vote with our constituents in mind; voiced disappointment of Ortiz's social media post that called out those who voted against resolution; hopes board remains professional and respectful of opinions.

Ortiz: the ethnic studies course will produce cultural competency; shared their opinion on their personal social media platform to their constituents in order to spread awareness of what's going on in student government, especially when the collective student voice votes against what would benefit the majority of students; looks forward to supporting a bill that addresses concerns and is implemented efficiently.

Williams: voiced support of an ethnic studies requirement, however, the current version is vague, and calls for unconditional support but doesn't address several significant impacts when implemented; suggested sending a list of concerns to send to Sacramento, or draft own version that addresses CSULB specific concerns.

Deng: voting on this board calls for the putting away personal biases to properly represent and make decisions in the interests of the student body; voiced concern on impacted majors; important to understand the bill and hold the chancellor and CSU Board of Trustees accountable that these are courses that benefit CSU students and are ones that they desire.

Hernandez: voiced concern that resolution failed in its first reading because it gives the incorrect perception ASI doesn't care about students; we're here for students, not faculty.

Almahdi: reports are due by 12pm tomorrow; will send out end of year reports by the end of this week; elections deadline was extended till Friday; AB1460 Open Forum on Tuesday, 7pm, Los Alamitos Bay.
