 - The Spring Grant Allocation application filing period has closed; grants will be reviewed by the BOC for approval

 - Completed an application for payroll protection program, which is part of the stimulus program; provides support for small nonprofit organizations; money is mostly free at very low interest rates; applying for those funds to maintain payroll
 - Completed application for loss recovery
 - Distributed a message to all ASI Student Employees regarding payroll extension
 - Doing a lot of programming for IPCDC, Rec Center, Beach Pride Programs and ASI Government to keep things running

11. CLOSING COMMENTS

Deng: Current economic bill stated that high education institutions received a lot money; CSULB is said to have received around 40 million dollars; 50% of that money have to be allocated towards student emergency grants.

Williams: applied for and was granted an emergency grant; however, couldn't receive any money because the criteria stated that you have to exhaust all of your financial aid/loan and increase your cost of attendance. If I increased cost of attendance then I would get more loan. I could not get any money from that emergency grant despite being eligible.

Nevin: 21 million dollars that university has for the direct support of students; CSULB presidents have been meeting and talking about it; don't believe that students aid packages impact this funding; being treated just like student checks; President Conoley is talking about it; will share specific information as soon as we know more.

Jarvis: Is there going to be any notification for faculty regarding the Basic Needs Resolution?

Almahdi: sent it to the Academic Senate so they can decide the best way to move forward with it; Dr. Kelly showed me some language that the other campuses implemented which I can share.

Williams: offered examples listed on their syllabi.

Almahdi: Senator of the Year nomination due to San Miguel by 5pm today!
