- WHEREAS** the Associated Students Incorporated Board of Directors at California State University, Long Beach is a recognized voice for over 37,000 students; and,
- WHEREAS** in 2016 a research study conducted by Dr. Rashida Crutchfield revealed that 24% of students within the California State University (CSU) system are food insecure¹; and
- WHEREAS** the Beach Pantry was officially opened in Fall 2016 to operate as the official food pantry for CSULB students to utilize²; and,
- WHEREAS** all CSULB students are able to access free food items as well as school supplies and menstrual hygiene products through the Beach Pantry; and,
- WHEREAS** CSULB is one of the largest campuses in the CSU system and was one of the first three campuses to implement a food pantry for students³; and
- WHEREAS** since the creation of the Beach Pantry in Fall 2016, it has accumulated over 18,000 single visits and surpassed 3,500 recurring visits; and,
- WHEREAS** the Student Emergency Intervention and Wellness Program is an initiative that provides at-risk students with housing, meals, counseling, and emergency funds to offer immediate support to students experiencing unexpected emergencies; and,
- WHEREAS** Dr. Ingrid Martin and their cohort generously contributed personal funds to provide 850 meals to the Beach Pantry and Student Emergency Intervention and Wellness Program; and,
