#### A. Chair:

Inieto reported that she attended the ACUI Region 1 Conference in San Diego in November. She found the conference inspirational.

#### B. Vice-Chair:

Torres reported that she attended the ACUI Region 1 Conference in November, 2018.

# C. USU Management Report:

Cicero reported that the MEP Project had moved forward. Renovations on the third floor restrooms had begun.

Facilities Maintenance Crew presented at the ACUI Region I Conference. A large beehive was removed outside the Student Recreation and Wellness Center. A new sound system was installed in the Game Center TV lounge and bowling lanes.

Conscious Collection was added to the gallery on December 6, 2018. Seventy-two ASI collaborators attended the Belmont Shore Christmas Parade, which was held on December 1, 2018.

Week of Welcome applications were opened for the spring 2019 semester. It would be held on January 30 & 31, 2018. Beach Pride would be hosting finals week activities, which would include snack giveaways and evening dinners.

ASI Communications covered 37 events and programs including Homecoming, Ballot Bash, and An Evening with Shiza Shahid Web updated and revised BEACHPRIDE.COM and refreshed photos on ASIRECREATION.ORGPublic Relations secured a great amount of positive coverage with their headlines.

Commercial Services would be offering free bowling and free billiards during finals week.

Beach Pantry Usage highly increased this past semester with 17,130 uses.

The Beach Pantry received a variety of donations, including \$2,000 from alumni and 700 lbs. of canned food from Facilities Management.

Three hundred canned food items were donated during the Fall into Giving month at the SRWC. Finalists were interviewed for the SRWC Membership Services & Outreach Coordinator position. Dog Therapy was held on December 6 and had over 300 participants. 5,367 students had signed up for the Owen's Condition for Tuition. All SRWC departments would be hiring for the spring semester. The SRWC had record usage number for October with 87,758 visits.

Cicero clarified that the dogs used in the Dog Therapy program were therapy dogs and each participant had 10 minutes with the dogs.

#### D. Senate Report:

Rubi reported that the Senate passed a resolution in support of transgender students. This resolution would highlight the resource available to them. A resolution to create electronic instructor evaluations would be implemented.

# **Campus Relations:**

Rodriquez reported that students would soon have easier access to the social media pages with the new QR codes.

#### **Facilities:**

Facilities Committee would be reviewing the USU and SRWC Night Safety Walk summary report and recommendations during the December 10 meeting. The 2019-2020 Operating Calendars would be presented and reviewed at the meeting as well.

Balayan clarified that the Chief Diversity Officer would know the scheduled date of the General Campus Night Walk.

### **Program Evaluation:**

Velazquez reported that the committee agreed to move the art gallery review to the next meeting in January.

#### **Services:**

Torres reported that the Beach Pantry chose 20 families from the IPCDC to participate in the We Got Your Backpack Program.

The Career Development Center and the ASI Executives were collaborating to create a clothing closet for students in need of business-professional clothing.

Torres reminded the board to utilize their UBucks that they received at the previous meeting.

Hung reported that the Academic Senate had their last meeting of the semester.

The Global Language and Translation Studies Center was opened and would be available in the spring of 2019.

Hanson reminded the board that Cherishing the Children at the Pointe would be on December 12.

Richardson reported that Beach 2030 had 3,665 participants. 24.8% of those were positive and 45% were undergraduate students.

### 1. Action Item: 2018 – 2019 USU Master Signage

There were updates and additions to the Master Signage, which included renaming the University Student Union (USU) Marketing Department to ASI Communications and changing "he/she" to "they."

Inieto clarified that CEC was an abbreviation for the Conference and Events Center. Richardson suggested that CEC be spelled out in the future.

Cicero noted that CEC would be changing to Conference Event Service Center so that it would be inclusive to all campus events.
